- **Products Marketing:** Ensures that the marketing of financial products aligns with the regulations in the targeted country and respects local laws and regulations.
- Product Documentation: Concludes by analyzing the documentation PRIIPs KID relevant to: UCITS, AIFs and structured products.

Indigita's new e-Learning course is designed for financial professionals seeking to enhance their understanding of MiFID II, ensuring compliance in the distribution and marketing of financial products within the EEA region. This course combines theoretical knowledge with practical scenarios to help participants navigate the complexities of the regulatory landscape effectively.

The e-Learning is SAQ certified and takes approximately 30 minutes to complete. It concludes with a final assessment to validate participants' learning progress. Upon completion, participants will receive a certificate.
